DEAR PASTOR/SCHOOL ADMINISTRATOR,

SIX MONTHS AFTER BECOMING PASTOR OF MY FIRST CHURCH, WE STARTED A CHRISTIAN SCHOOL. THAT WAS OVER THIRTY-FIVE YEARS AGO, AND SINCE THAT TIME I HAVE NOT BEEN PASTOR OF A CHURCH WITHOUT A SCHOOL MINISTRY. I FIRMLY BELIEVE IN CHRISTIAN EDUCATION.

EDUCATION BELONGS TO THE HOME, AND HOME-SCHOOLING EDUCATION HAS BECOME VERY POWERFUL IN OUR COUNTRY TODAY. WHERE THIS IS NOT POSSIBLE, THE BIBLE-BASED SCHOOL IS THE BEST PLACE TO PARTNER WITH PARENTS IN MEETING THEIR CHILDREN'S EDUCATION NEEDS. EDUCATION IN AMERICA WAS EVENTUALLY PLACED UNDER THE PURVIEW OF LOCAL COMMUNITIES, AND LATER SUPPLEMENTED BY FEDERAL FUNDS. IN THE MID-SIXTIES, GOD WAS EXPELLED FROM SCHOOL, WHEN PRAYER WAS FORBIDDEN IN THE CLASSROOM. SINCE THEN, THE TEN COMMANDMENTS HAVE BEEN REMOVED FROM EDUCATION AND THE HOMOSEXUAL AGENDA HAS REPLACED THEM IN PUBLIC SCHOOLS ACROSS THE COUNTRY. MEANWHILE, THE CHRISTIAN SCHOOL MOVEMENT BEGAN TO GROW IN EARNEST AND HAS BECOME A POWERFUL MOVEMENT IN AMERICA.

EARLY IN THE CHRISTIAN SCHOOL MOVEMENT, THE AMERICAN ASSOCIATION OF CHRISTIAN SCHOOLS WAS FOUNDED TO HELP PROVIDE TRAINING, INSPIRATION, AND PROFESSIONAL SERVICES TO SCHOOL STAFFS, AS WELL AS POLITICAL AND MORAL REPRESENTATION IN WASHINGTON D.C. AND IN STATE CAPITOLS.
